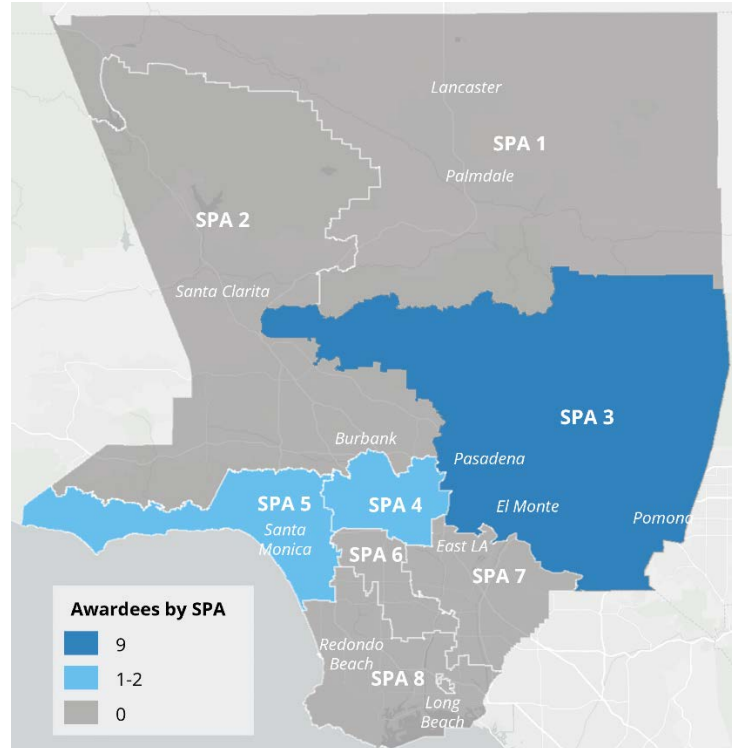


In 2025, following the devastating January wildfires that swept through Pacific Palisades and the Pasadena/Altadena area, the California Jobs First Los Angeles Collaborative launched the Wildfire Recovery and Resilience Fund—a \$1 million initiative to support community-driven efforts focused on long-term recovery, population displacement, and economic revitalization in wildfire-impacted areas of Los Angeles County. A joint review committee composed of staff from the California Community Foundation and HR&A Advisors evaluated proposals based on alignment with recovery strategies, community impact, and equity. After a rigorous review process, final recommendations were made. Awardees and project summaries are listed below.
